SUBJECT: PROJECT NO. 7230 – ACCEPT WORK FOR TRAFFIC SIGNAL IMPROVEMENTS – SAN ANTONIO DRIVE/NORWALK BOULEVARD BETWEEN ROSECRANS AVENUE AND CIVIC CENTER DRIVE, AND ON CIVIC CENTER DRIVE BETWEEN NORWALK BOULEVARD AND BLOOMFIELD AVENUE, FEDERAL PROJECT NO. HSIPL-5347(040) - ENGINEERS REPORT 24-20

Background:

On July 16, 2020, City Council awarded a contract to KDC, Inc. dba Dynalectric in the amount of \$950,814 and included a contingency of \$95,100 for the subject project.

The work scope included Traffic Signal Improvements on San Antonio Drive/Norwalk Boulevard between Rosecrans Avenue and Civic Center Drive, and on Civic Center Drive between Norwalk Boulevard and Bloomfield Avenue, Federal-Aid Project No. 5347(040). Additional work in the amount of \$720,233 was required for the additional procurement due to bid quantity differential, installation of traffic control devices which included additional boring for additional installation of conduit, additional restoration of asphalt paving and precast concrete in Caltrans Right-of-Way; additional Southern California Edison service work; additional conduit installation for future use at Bloomfield Avenue and Civic Center Drive and various additional work performed due to unforeseen conditions. Final project costs are \$1,671,048.

The project was completed satisfactorily on May 11, 2023.

Fiscal Impact:

The project was funded through HSIP Federal funds and Measure M matching as follows:

HSIP Federal Funds:	\$1,503,943	(90%)
Measure R (matching funds)	\$106,138	(6%)
Prop C (matching funds)	\$60,967	(4%)
Final Project Cost:	\$1,671,048	(100%)

No General Fund monies were used for the project.
