**SUBJECT: PROJECT NO. 7928.2 - ACCEPTANCE OF WORK FOR LOCAL STREETS
REHABILITATION PROGRAM ZONE 8 - ENGINEERS REPORT 24-13**

Background:

On June 16, 2023, staff solicited for construction bids for the Measure R funded City Project No. 7928.2 - Local Streets Rehabilitation Phase 2 roadway surface improvements. The project area is located within City Pavement Management Zone 8, bounded by I-105 freeway to the south, I-605 to the east, City limits to the west and Union Pacific Railroads to the north as shown on the attached map. R.J. Noble Company was selected as the contractor for this project.

The project scope improved roadway surface conditions through multiple rehabilitation methods consisting of grind and overlay, specific location full-depth removal/replacement, and slurry seal coating. All pavement markings (striping, legends, crosswalks, etc.) have been restored following paving operations. Crosswalks were upgraded to current continental standards where applicable for enhanced pedestrian safety.

The project was completed satisfactorily on May 2, 2024.

Fiscal Impact:

The project was funded using \$2,691,105 of Measure R funds that were included in the Fiscal Year 2023/24 budget. No General Fund monies were used for the project. Unexpended funds in the amount of \$438,379 are available for reprogramming.
