

10. 2025 CONSOLIDATED PLAN AND FISCAL YEAR 2025/26 ANNUAL ACTION PLAN  
Staff recommend City Council and the public provide input of the proposed Community Development Block Grant and HOME Investment Partnerships Program Consolidated Plan and funding activities for Fiscal Year 2025/26 Annual Action Plan.

### Social Service Agency Funding Information

On November 8, 2024, a notice of funding availability was published to announce that the City is accepting applications for CDBG funding for social service programs. The CDBG funding application was made available on *Planetbids*, posted on the City's website and published in *The Norwalk Patriot*. 51 organizations were notified directly. Applications were due December 13, 2024.

Currently, programs funded under the social services funding cap include:

- Emergency Assistance Program – Social Services Department
- Norwalk La Mirada Adult School Scholarship - Job Training Program
- Three (3) organizations (Jovenes, Community Legal Aid and Los Angeles Centers for Alcohol and Drug Abuse)

The table below shows the past 3 fiscal year performance of the social services agencies that have received CDBG funding. **Unexpended funds are reallocated in the subsequent fiscal year as carryover funds to any other eligible CDBG project that is not subject to a cap.**
