**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORWALK  
AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2024/25  
BUDGET FOR THE NORWALK PARK, HOLIFIELD PARK, AND  
ROBERT WHITE PARK PLANNING AND DESIGN PROJECT**

**WHEREAS**, the City of Norwalk has been allocated Technical Assistance Program funds from the County of Los Angeles Regional Park and Open Space District (RPOSD) in the amount of \$185,000 to assist in the development of new park land; and

**WHEREAS**, the City of Norwalk desires to complete Master Plans for Holifield Park, Norwalk Park, and Robert White Park to complete necessary park improvements and pursue federal and state grants; and

**WHEREAS**, the City Council desires to amend the project budgets and appropriate additional \$444,476 funding from, Park Renovation Fund and \$181,740 from County of Los Angeles Regional Park and Open Space District Grant to complete the Park Master Plans for Holifield Park, Norwalk Park, and Robert White Park.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NORWALK  
HEREBY DETERMINES, FINDS, AND RESOLVES AS FOLLOWS:**
